I want to submit some suggestions for better Law and order situation in the country-

1. Gurjar movement of Rajasthan for their ST status through amendment in IX schedule in the Constitution of India is disrupting the State and Country since one and half decade mainly by capturing the Delhi- Mumbai railway line at Peelupura, Bharatpur. Neither Central, nor State govt. could have been successful to remove them from railway lines and Highways.
