Sir,

First of all I want to congratulate our Chief Minister Sir and his entire team engaged in controlling the pandemic Covid-19, very effectively in Rajasthan , in comparison to other States. I need to draw your attention on following issues-

1. RT-PCR testing centers are having very heavy work load with huge queues every time, everywhere and such the situation spreads the pandemic to those persons who are not infected. Also open these centres 24x7 basis and staff must be deputed on three shifts like hospital duties. May please provide freedom to the citizens/patients to get their test done at any centre.
2. Due to shortage of vaccines there is mess/ chaos at almost every vaccination centre and this situation also spreads infection. If everything is on portal, then why we can not provide fix time slot of every 15 minutes(i.e.- 9.0 to 9.15 five persons ABCDE , 9.16 to 9.30 five persons EFGHI----so on) to each registered person per day between 9am to 3pm and after 3 pm take the defaulters of the day..
- 3.If you want to know the exact number of dead persons due to Covid-19, just declare a scheme that Rs. 5000/- (just an example) will be given to the family of such persons after submitting the application and relevant documents. You will receive all the data within fortnight .
4. In this panic situation there is a term which is completely missing that is -"scientific temper" and it was given by Pt. Nehru and also mentioned in our fundamental duties. May kindly include it in syllabi of school and college education and also launch a 'programme on scientific temper and health education' in post- covid management strategies. I offer my services for this programme.
